The total land area of the project is 831.367 acres and built up area is 30,95,783 Sqm. The project is covered under category 8(b) of the schedule appended with the EIA Notification dated 14.09.2006 and its subsequent amendments and requires appraisal at the State level.

- 4) The proposal has been appraised as per the procedure prescribed under the provisions of EIA Notification 14.09.2006 based on mandatory documents enclosed with the online application viz Form-1, Environment Management Plan (EMP), conceptual plan, and additional documents and subsequent presentation /clarifications made by the project proponent and his consultant to the observations of State Environment Impact Assessment Authority (SEIAA) and State Expert Appraisal Committee (SEAC).

- 6) As per the undertaking submitted by the project proponent, the project site is located at a distance of 9.5 Km from Sukhna Wild Life Sanctuary and they have applied for obtaining clearance from NBWL. Further, as per undertaking submitted by the Project Proponent, no litigation is pending in respect of the land on which the project is to be developed and no forest land is involved thus the proposal does not require approval/clearance under the Forest Act, 1980.
- 7) The SEAC, constituted under the provision of the EIA Notification, 2006 and comprising of expert members / domain experts in various fields, has examined the proposal submitted by the project proponent in the desired form along with the EMP report prepared and submitted by the consultant accredited by the Quality Council of India (QCI)/ National Accreditation Board for Education and Training (NABET) NABET on behalf of the project proponent in its 296th meeting held on 01.07.2024 and 298th meeting held on 13.07.2024. The SEAC noted that the project proponent has given an undertaking that the data and information given in the application and enclosures are true to the best of his knowledge and belief and no information has been suppressed in the report. If any part of the data/information submitted is found to be

false/misleading at any stage, the project may be rejected and Environmental Clearance given, if any, may be revoked at the risk and cost of the project proponent.

- 8) SEAC noted that the project proponent has provided adequate and satisfactory clarifications to the observations raised by it. Therefore, SEAC decided to forward the case to the SEIAA with the recommendation to grant Environmental Clearance for development of Township Project namely "Omaxe New Chandigarh" located at Village Kansala, Ranimajra, Dhodemajra, Rasoolpur, Salamatpur, Paraul, Bharonjian, Ghandouli, Bhagat Majra, Saini Majra, Bansepur, Paintpur, Chahar Majra & Sanglan, Mullanpur, Tehsil Kharar, District, Mohali, Punjab. The total land area of the project is 831.367 acres and built up area is 30,95,783 Sqm, as per the details mentioned in the application proposal & subsequent presentation /clarifications made by the project proponent and his consultant.
- 9) The case was considered by SEIAA in its 303rd meeting held on 19.07.2024 wherein SEIAA observed that the case stands recommended by SEAC. The Authority examined all the aspects of the project proposal in detail and was satisfied with the same. Therefore, the Authority decided to grant Environmental Clearance for area development of Township Project namely "Omaxe New Chandigarh" located at Village Kansala, Ranimajra, Dhodemajra, Rasoolpur, Salamatpur, Paraul, Bharonjian, Ghandouli, Bhagat Majra, Saini Majra, Bansepur, Paintpur, Chahar Majra & Sanglan, Mullanpur, Tehsil Kharar, District, Mohali, Punjab. The total land area of the project is 831.367 acres and built up area is 30,95,783 Sqm, as per the details mentioned in the Form-1, EMP, conceptual plan and subsequent presentation /clarifications made by the project proponent and its consultant with proposed measures and subject to conditions proposed by SEAC and certain additional conditions and amended conditions.
- 10) Accordingly, SEIAA, Punjab hereby accords Environmental Clearance to the aforesaid project under the provisions of EIA Notification dated 14.09.2006 and its subsequent amendments subject to proposed measures and strict compliance with terms and conditions as per Annexure-1.
- 11) The SEIAA reserves the right to stipulate additional conditions if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time-bound manner. SEIAA may revoke or suspend the environmental clearance if the implementation of any of the above conditions is not found to be satisfactory.
- 12) Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- 13) This issues as per the decision taken by the Competent Authority.
