Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of Sanvim Developers Private Limited ("the Company"), which comprise the Balance Sheet as at 31° March 2022, the Statement of Profit and Loss, the Cash Flow statement and the Statement of changes in Equity for the year ended on that date and notes to the financial statements, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the financial statements").

1.Corporate information
