

Details of the violation(s)/contravention(s) eommitted or alleged to be committed	The Noticees were alleged to have violated the various provisions of SEBI (LODR) Regulations, 2015, Listing Agreement, SEBI (Prohibition of Fraudulent and Unfair Trade Practices relating to Securities Market) Regulations, 2003, SEBI Act, 1992, Companies Act, 2013 and applicable Accounting Standards.
5.	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	There is no material impact on the financial, operation or other activities of the Company pursuant to the said Order except as explained under point No. 2 above.

Details of penalty/fine imposed by SEBI vide its Order No. QJA/GR/CFID/CFID/30598/2024-25 dated July 30, 2024 under Sections 11(1), 11(4), 11(4A), 11B (1) and 11B (2) of Securities and Exchange Board of India Act, 1992 and Rule 5 of the SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995

- 1. The Noticee No. 1 to 6 i.e. Omaxe Limited, Mr. Rohtas Goel, Mr. Mohit Goel, Mr. Sudhangshu S. Biswal, Mr. Arun Kumar Pandey and Mr. Vimal Gupta have been restrained from accessing the securities market and further prohibited from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of two years, from the date of coming into force of said order;
- 2. The Noticee No. 2 to 6 i.e. Mr. Rohtas Goel, Mr. Mohit Goel, Mr. Sudhangshu S. Biswal, Mr. Arun Kumar Pandey and Mr. Vimal Gupta have been prohibited from holding any position as Director or Key Managerial Person of any other listed company for a period of two years.
- 3. The Noticee No. 1 i.e. Omaxe Ltd. have been imposed a fine of Rs. 7,00,000/- (Rupees Seven Lakh Only), the Noticee No. 2 to 6 i.e. Mr. Rohtas Goel, Mr. Mohit Goel, Mr. Sudhangshu S. Biswal, Mr. Arun Kumar Pandey, Mr. Vimal Gupta have been imposed with the penalty of Rs. 6,00,000/- (Rupees Six Lakh Only) each and the Noticee No. 7 to 16 i.e. Mr. Sunil Goel, Ms. Nishal Jain, Mr. Gurnam Singh, Mr. D.K. Kambale, Mr. Sudip Bandyopadhyay, Ms. Shruti Dvivedi Sodhi, Mr. Prem Singh Rana, Mr. Bhopinder Singh, Mr. Navin Jain and Ms. Shubha Singh have been imposed with the penalty of Rs. 1,00,000/- (Rupees One Lakh Only) each.
